

### Sri Sri Academy Modern United Nations Fourth Edition 29th September - 1st October 2019 The Opening Ceremony

SSMUN 2019 began with a solemn gathering of around 16 schools and over 250 delegates abiding by the customary start with a cultural performance by the school band, Enigma. This was the first national edition since we had an outstation school from Ooty participating in the conference. The ceremony was followed by speeches delivered by Professor Jayanta Sengupta, the curator of Victoria Memorial and Mikhail V Gusev, the Deputy Consul of Russian Federation. The program was carried on by the Secretary General of this year's edition of the SSMUN. The Secretary General, had successfully laid down the aims and aspirations of this series of events. By the end of the speech, the three-day program was declared open with a bang on the gavel.

















#### UNITED NATIONS GENERAL ASSEMBLY: Open Elimination of Racism and Racial Discrimination

#### UNITED NATIONS SECURITY COUNCIL: Addressing the Suez Canal Crisis and the Hungarian Revolution

The Conundrum of the Hypocrites - The Historic Security Council

28 October 1956: As the committee settled down to discuss the predicament that had erupted in the Suez Canal region due to Egypt's President Nasser's declaration of nationalizing the canal.

The United Kingdom had been a fervent critic of hypocrisy throughout the committee and in the end, it violated Resolution 118 of the UNSC.

After a round of voting, it was clear that the committee unanimously wanted the United Kingdom not to interfere into the Suez Canal anymore for it had done enough. USA,Soviet Union, Egypt, Brazil and Turkey were the five members voted as the members of the said body.





# JOINT CRISIS COMMITTEE (AXIS CABINET AND ARCADIA): Formulation of Wartime Strategies Post the Attack on Pearl Harbour

Some delegates proposed creative, well thought out plans such as engaging America in a naval battle as America had not engaged in naval battles and spreading false information amongst the Allies' midst while other delegates brought forward blunt strategies such as simply attacking British colonies in Africa and conquering the Suez canal. The importance of defeating rising colonial powers like America was strongly repeated and the fact that the Axis had the powers and the resources to win the war was strongly emphasized. The first crisis in the committee was the leakage of the top-secret information of the heavy water plant situated in Norway that belonged to the Germans. The British reacted to this news by sending ten paratroopers to attack the water plant.





The committee then began to try and find out who the mole is so as to prevent leakage of information. Many delegates pin pointed the Ministry of Hungary as the mole without any solid proof. They proposed that the Ministry of Hungary was the mole and had to be thrown out of the committee with their reason being that the Minister isolated himself from others and they refused to consider that the Minister had opinions of his own.





The Chair's reaction to the release of a press statement made by the Ministry of War of Bulgaria that said that the Minister of Finance of Bulgaria was to be assassinated as he was not allocating any money was simply put hilarious.









#### LOK SABHA: Discussion on Article 370

The proceedings started with the BJP defending their stance on why the removal of Article 370 would be effective and beneficial while the UPA was constantly adhering to the problems faced by the residents of Jammu and Kashmir. "They have the right to choose their way of living" said Mahua Moitra (MP from the TMC).
